## **DESCRIPTION:**

Product is the lyophilized powder of goat antiserum to dog IgM ( $\mu$  chain) and buffer salts.

The antiserum is prepared by hyperimmunizing goats with highly purified dog IgM; antiserum is delipidated and made specific by solid-phase absorption. The resulting antiserum is dialyzed into 0.02M sodium phosphate, 0.14M sodium chloride, pH 7.3, with 0.05% sodium azide, adjusted to standard titer, filtered through a 0.22  $\mu$ m filter, vialled and lyophilized.

## **USES:**

This product is suitable for use as a precipitating antibody. It gives sharp precipitin lines in immunoelectrophoresis and immunodiffusion techniques.

(Note: IgG fractions are suitable for conjugation with enzymes, radiolabels, fluorochromes or other markers and for attachment to solid supports for use as an immunoabsorbant. See **Related Product Ordering Information** for these products.)

## **SPECIFICATIONS:**

The total protein is measured using the Biuret procedure, with bovine albumin as a standard. Antibody titer is standardized with an in-house control by immunoelectrophoresis. Each antiserum is tested for specificity at a minimum of 80 mg/ml using immunoelectrophoresis. It shows reactivity to dog IgM; cross-reactivity to other species may exist. Antibody activity to dog IgG or non-immunoglobulin serum proteins is not present.

## **EXPIRATION DATE:**

## **RECONSTITUTION:**

Reconstitute product with 2.0 ml of deionized or distilled water. Gentle swirling may be used to speed rehydration. Avoid vigorous shaking of the reconstituted material.

## **STORAGE:**

Store lyophilized product at 2-8°C. Store reconstituted material no longer than 4 weeks at 2-8°C. For long-term storage, aliquot and freeze reconstituted product at -20°C or lower.


